SmartHealth is focused on providing you exceptional healthcare at affordable prices. That's why we offer benefits that help reduce out-of-pocket costs without compromising your quality of care.

### **Explore cost-saving benefits:**

- <u>Tier 1 providers</u>: Choosing providers within the Ascension Network (Tier 1) reduces your out-of-pocket costs and improves your experience by giving your care team streamlined access to your health history for personalized care.
- <u>Tier 1 Labs</u>: When working with your Ascension provider to plan for labs services such as [insert examples], be sure those facilities are approved Tier 1 facilities or you could pay more.
- <u>Ascension Rx</u>: Moving your prescriptions to Ascension Rx helps you avoid full out-of-pocket costs for outpatient maintenance and specialty medications.
- <u>In-network urgent care clinics</u>: SmartHealth ensures you have access to affordable and convenient care at urgent care clinics. PPO members now have reduced copays for Tier 1 (\$50) and Tier 2 (\$75) urgent care providers. Virtual visits through <u>Amwell</u> are also available at a reduced rate.
- <u>Spending accounts</u>: If you're enrolled in a health savings account (HSA), flexible spending account (FSA) or dependent care FSA, you can use pre-tax dollars to cover eligible expenses. You can increase your savings by contributing up to the maximum amount each year.
- 2025 contribution limits (minimum and maximum amounts):
  - HSA: \$4,300 individual / \$8,550 family (no minimum)
  - FSA: \$260 \$3,200
  - Dependent care FSA: \$260 \$5,000
