#### Upcoming changes to COVID-19 coverage

Inpatient treatment will be covered at 100% (any tier level), without deductibles, coinsurance or copays, through **December 31, 2022**. Standard cost sharing will apply thereafter. Mandated coverage will continue until the public health emergency is lifted.

#### Beginning January 1, 2023, SmartHealth is changing the Tier 2 Network to the Blue Cross Blue Shield - Illinois (BCBS-IL) Select Network - ILARL only
